SPECIAL INFORMATION AND INSTRUCTIONS RE FILING APPLICATION FOR SOUTHERN CALIFORNIA IBEW-NECA PENSION PLAN BENEFITS

1. RECIPROCAL AGREEMENTS

This Plan has reciprocal Agreements with the following IBEW Locals: 48, 100 (from 07/01/71), 112, 280, 332 (thru 12/31/93), 357, 428, 482, 497, 551, 569, 659, 932, and 1547. Locals participating in this Plan: 11, 440, 441, and 477.

2. **C – 10 LICENSE**

If you have a C-10 or other electrical contracting license prior to the commencement of Pension benefits, this license must be inactivated, or you must disassociate yourself from the license, before benefits can become effective. A copy of the Inactive License or Notice of Disassociation from the Contractors State License Board must be sent to Pension Fund Administrative Office. Pension effective date can be no earlier than the first of the month following the month in which the license is inactivated or the Notice of Disassociation filed with the Contractors State License Board. Further, if after retirement benefits have commenced a retiree under this Plan is issued a C-10 or other electrical contracting License, the Pension Office must be notified, and benefits may be temporarily suspended for the period of time the license is active, depending on your age and other considerations.

3. PROOF OF AGE – INSTRUCTIONS CONCERNING SUBMISSION OF PROOF OF AGE

The acceptable proofs of age are listed below in two groups. Submit a photostatic copy of one of the proofs listed in Group I, if you have it or can possibly obtain it, since this class of proof of age is more convincing. If you cannot submit a proof in Group I classification, submit photostatic copies of two of the proofs listed in Group II.

You are cautioned, however, that Naturalization papers, United States passports and immigration papers must not be photocopied. If you are submitting any of these, you MUST submit the original. It will be returned to you. Additional proofs of age may be requested if the documents you submit do not constitute convincing proof of your age.

GROUP I

- 1 A birth certificate
- 2. A baptismal certificate or a statement as to the date of birth
- 3. Notification of registration of birth in a public registry of vital statistics
- 4. Certification of record of age by the U.S. Census Bureau
- 5. Hospital birth record, certified by the custodian of such record
- 6. A foreign church or government record
- 7. A signed statement by the physician or midwife who was in attendance at birth, a to the date of birth shown on their records
- 8. Naturalization record (Photocopy not permitted; submit original)
- 9. Immigration papers (Photocopy not permitted; submit original)

GROUP II

- 1. Military record
- 2. Passport (U.S. passports may not be photocopied; submit original)
- 3. School records, certified by the custodian of such record
- 4. Vaccination record, certified by the custodian of such record
- 5. An insurance policy which shows the age or date of birth
- 6. Marriage records showing date of birth or age (application for marriage license or church record, certified by the custodian of such record, or marriage certificate)
- 7. Other evidence such as signed statements from persons who have knowledge of the date of birth.
