

SUMMARY ANNUAL REPORT

FOR SOUTHERN CALIFORNIA IBEW-NECA SUPPLEMENTAL UNEMPLOYMENT BENEFIT TRUST FUND

This is a summary of the annual report of the Southern California IBEW-NECA Supplemental Unemployment Benefit Trust Fund, E.I.N. 46-7214939, Plan No. 501, for the year ended **June 30, 2022**. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was **\$33,664,840** as of **June 30, 2022**, compared to **\$30,733,514** as of **July 1, 2021**. During the plan year, the plan experienced an increase in its net assets of **\$2,931,326**. During the plan year, the plan had total income of **\$3,530,430** including employer contributions of **\$6,519,594** and **loss** from investments of **\$2,989,164**.

Plan expenses were **\$599,104**. These expenses included **\$314,152** in administrative expenses and **\$284,952** in benefits paid to participants.

If you request a copy of the full annual report from the Plan Administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (100 Corson Street, Suite 200, Pasadena, CA 91103) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
