CITY OF PASADENA HEALTH OFFICER ORDER FOR THE CONTROL OF COVID-19

ORDER TO COMPLY WITH CALIFORNIA DEPARTMENT OF PUBLIC HEALTH BLUEPRINT FOR A SAFER ECONOMY - PURPLE TIER

This Order Issued: January 27, 2021

This Order is in effect as of 12:01 AM January 28, 2021 until rescinded in writing by the Health Officer.

Please read this Order carefully. Violation of or failure to comply with this Order is a crime punishable by fine, imprisonment, or both. (California Health and Safety Code §120295.)

SUMMARY OF THE ORDER: California is in a State of Emergency because of the COVID-19 pandemic. The spread of COVID-19 is a substantial danger to the health of the public within the City of Pasadena. COVID-19 can easily spread between people who are in close contact with one another. Everyone is at risk for becoming ill with COVID-19, but some people are more vulnerable to serious illness, including pneumonia and organ failure, or death, due to their age, physical state, and/or health status.

The City of Pasadena Health Officer ("Health Officer") has issued a number of Orders to help slow COVID-19's spread, protect vulnerable individuals, and prevent the healthcare system in and around the City of Pasadena from being overwhelmed. The Revised Safer at Home Orders, dated March 22, 2020 and supplemented April 11 and May 15, 26 and 29, June 11, 18 and 28, 2020, and July 1 and 14, 2020 issued by the Health Officer, as amended (https://www.cityofpasadena.net/public-health/health-order/covid-19/) as well as other "Safer at Home" orders issued by other jurisdictions have proven to slow the spread of COVID-19.

This Order directs all individuals and businesses to comply with Tier 1 (Purple) of the Blueprint for a Safer Economy, issued by the California Department of Public Health ("CDPH") on August 28, 2020, as periodically updated by the CDPH and as implemented by the protocols set forth by the Health Officer.

This Order supersedes all previous Health Officer Orders that are not consistent with the terms of this Order.

Except as provided for herein, all previous orders of the Health Officer remain in full force and effect.

UNDER THE AUTHORITY OF THE CALIFORNIA HEALTH AND SAFETY CODE SECTIONS 120175 et seq., AND THE PASADENA MUNICIPAL CODE SECTION 8.04.010, THE CITY OF PASADENA HEALTH OFFICER ORDERS:

- 1. This Order requires all individuals and businesses to comply with the restrictions and limitations set forth in Tier 1 (Purple) of the Blueprint for a Safer Economy, issued by the CDPH on August 28, 2020 as periodically updated by the CDPH https://covid19.ca.gov/stay-home-except-for-essential-needs/#stay-home-order, and as implemented by the protocols established by the Health Officer as set forth herein https://www.cityofpasadena.net/covid-19/#guidance-faq-protocols:
 - Restaurants may open for takeout, delivery, and outdoor dining services, in compliance with the protocol for restaurants;
 - Bars and breweries that are not able to provide a sit down, bona fide meal with each alcohol transaction must remain closed;
 - Retail may operate at 25% capacity (as defined by fire code) in compliance with the protocol for retail operations;
 - Essential retail, such as grocery stores, may operate at 50% capacity (as defined by fire code) in compliance with the protocol for essential retail operations;
 - Hair salons may operate indoors with modifications, in compliance with the protocol for hair salons;
 - Personal care services may operate indoors at 25% capacity with modifications, in compliance with the protocol for personal care services;
 - Museums and galleries may open for outdoor operations only in compliance with the protocol for museums and galleries;
 - Places of worship may only conduct in-person services outdoors in compliance with the protocol for places of worship;
 - Movie theaters may only operate outdoors in compliance with the protocol for drivein movies;
 - Hotels may operate with modification in compliance with the protocol for hotel;
 - Fitness facilities may operate outdoors only in compliance with the protocol for fitness facilities;
 - Music, TV, and film production may operate with modifications, in compliance with the protocol for music, TV, and film production;
 - Essential offices may operate in compliance with the protocol for office workspaces (essential work as defined at https://covid19.ca.gov/essential-workforce/). Non-essential offices may open for remote work only;
 - Professional sports may resume with no live audiences, with modifications in compliance with the protocol for professional sports.
- 2. Private outdoor gatherings are subject to the restrictions set forth in the order issued by the Health Officer on October 15, 2020 https://www.cityofpasadena.net/public-health/wp-content/uploads/sites/32/Restrictions-on-Dining-Establishments-Personal-Care-Service-Establishments-and-Private-Gatherings.pdf, including but not limited to:

- a. Gatherings should be limited to no more than three households
- b. Gatherings should be held outside and last no longer than 2 hours
- c. Attendees should maintain at least 6 feet physical separation from all other attendees who are not part of the same household or living unit
- d. Singing, chanting and shouting are strongly discouraged
- 3. K-12 schools are subject to the <u>COVID-19 and Reopening In-Person Instruction</u>
 Framework & Public Health Guidance for K-12 Schools in California, 2020-2021 School
 Year and additional requirements in the protocol for K-12 schools
 https://www.cityofpasadena.net/covid-19/#info-for-schools.
- 4. All other previous orders of the Health Officer, as revised, supplemented and/or amended, remain in full force and effect, except as provided herein. To the extent a conflict exists between this Order and previous orders, the previous orders are hereby superseded.
- 5. The CDPH has declared that the Q&A and Industry Guidance set forth on the CDPH COVID-19 website have the same force and effect as other State Public Health Officer directives. By way of this Order, the Health Officer adopts such directives as orders as well.
- 6. Protocols established by the Health Officer to implement health orders issued by the State Public Health Officer or the City of Pasadena Health Officer have the same force and effect as other Orders issued by the Health Officer. To the extent any health order of the Health Officer, including any protocols established to implement any health order, is more restrictive than any order or directive issued by the State Public Health Officer, the health order of the Health Officer shall control.
- 7. This Order's intent is to continue to ensure that City residents remain in their residences as much as practicable, to limit close contact with others outside their households in both indoor and outdoor spaces. All persons who can telework or work from home should continue to do so as much as possible during this pandemic. All non-essential offices must continue to operate remotely, without in-person operations. Nothing in this Order prohibits members of a single household from engaging in activities together, but gatherings of people who are not part of a single household or living unit are subject to restrictions as set forth in paragraph 2, above, within the City of Pasadena Public Health Jurisdiction, except for the limited purposes expressly permitted by this Order.
- 8. People leaving their residences as permitted by this Order must strictly comply with physical distancing measures, including: maintaining six feet or more of distance between individuals from different households, frequently washing hands with soap and water for at least 20 seconds or using hand sanitizer that contains at least 60 percent alcohol, and wearing a face covering over the nose and mouth whenever there is or can be contact with others who are non-household members in both public and private places, whether indoors or outdoors, for the purposes of source control.
- 9. This Order applies to all persons within the City of Pasadena under the Health Officer's

jurisdiction.

- 10. Violation of this Order is a misdemeanor punishable by imprisonment, fine or both under California Health and Safety Code Section 120295. This Order will be enforced by the City of Pasadena Police Department, City Attorney/City Prosecutor's Office, and/or any other agency designated by the Pasadena City Manager for enforcement.
- 11. If any subsection, sentence, clause, phrase, or word of this Order (or any other prior Order) or any application of it to any person, structure, gathering, or circumstance is held to be invalid or unconstitutional by a decision of a court of competent jurisdiction, then such decision will not affect the validity of the remaining portions of this Order (or any other prior Order).
