

SUMMARY ANNUAL REPORT
FOR SOUTHERN CALIFORNIA IBEW-NECA PENSION TRUST FUND

This is a summary of the annual report for the Southern California IBEW-NECA Pension Trust Fund, E.I.N. 95-6392774, Plan No. 001, for the year ended **June 30, 2009**. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were **\$95,227,222**. These expenses included **\$6,435,458** in administrative expenses and **\$88,791,764** in benefits paid to or for participants and beneficiaries. A total of **14,638** persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was **\$773,846,221** as of **June 30, 2009**, compared to **\$975,462,807** as of **July 1, 2008**. During the plan year the plan experienced a decrease in its net assets of **(\$201,616,586)**. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of **(\$106,389,364)** including employer contributions of **\$53,906,610**, realized losses of **(\$47,982,698)** from the sale of assets, losses from investments of **(\$112,916,013)**, and other income of **\$602,737**.

Minimum Funding Standards

An actuary's statement shows that enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.

Your Rights To Additional Information

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. An independent auditors' report;
2. financial information and information on payments to service providers;
3. assets held for investment;
4. transactions in excess of 5% of the plan assets; and
5. actuarial information regarding the funding of the plan.

The charge to cover copying costs will be \$10.50 for the full annual report, or 25 cents per page for any part thereof.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (6023 South Garfield Avenue, City of Commerce, CA 90040-3608) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
