SUMMARY ANNUAL REPORT

FOR SOUTHERN CALIFORNIA IBEW-NECA DEFINED CONTRIBUTION PLAN

This is a summary of the annual report for the Southern California IBEW-NECA Defined Contribution Plan, E.I.N. 95-0079082, Plan No. 002, for the year ended **June 30, 2011**. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$73,003,526. These expenses included \$4,069,491 in administrative expenses, \$28,549,821 in benefits paid to or for participants and beneficiaries, and \$7,707,633 in deemed distributions, and transfers out of \$32,676,581. A total of 18,449 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$549,092,882 as of June 30, 2011, compared to \$523,164,788 as of July 1, 2010. During the plan year the plan experienced a increase in its net assets of \$25,928,094. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$98,931,620 including employer contributions of \$29,902,815, realized gains of \$29,815,053 from the sale of assets, income from investments of \$38,843,945, and other income of \$369,807.

Minimum Funding Standards

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.
