ELIGIBILITY FOR BENEFITS

How Do I Become a Participant?

You become a Participant in the Plan by working for an Employer required by a Collective Bargaining Agreement or Participation Agreement to make contributions to the Supplemental Unemployment Benefit Trust Fund on your behalf.

How Do I Become Eligible for Benefits?

Once you become a Participant in the Plan, you will become eligible for Supplemental Unemployment Benefits upon meeting all of the following eligibility requirements:

- Successful Completion of Mandatory Day School: Successfully completing Mandatory Day School through the Electrical Training Institute. Proof of attendance and successful completion is required; and
- Hour Requirement: You must meet the hour requirement by working a minimum of 1,040 hours in Covered Employment in either the four (4) Contribution Quarters prior to attendance in Mandatory Day School or the 12-Month Review Period; and
- Application for Southern California IBEW-NECA Supplemental Unemployment Benefits: An application for Southern California IBEW-NECA Supplemental Unemployment Benefits must be filed with the Administrative Trust Funds Office.
