SUMMARY ANNUAL REPORT

FOR SOUTHERN CALIFORNIA IBEW-NECA HEALTH TRUST FUND

This is a summary of the annual report of the Southern California IBEW-NECA Health Trust Fund, E.I.N. 95-6140101, Plan No. 501, for the year ended June 30, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Anthem Blue Cross Life and Health Insurance Company, Vision Service Plan, Delta Dental of California, United Concordia Dental Plans of California, Kaiser Foundation Health Plan, Inc., Optum, UnitedHealthcare of California, Blue Shield of California and The Standard to provide certain benefits incurred under the terms of the plan. The total premiums paid for the plan year ended June 30, 2024 was \$151,525,062.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ended June 30, 2024, the premiums paid under such "experience-rated" contracts were \$7,248,036 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$6,416,097.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$34,312,382 as of June 30, 2024, compared to \$17,246,185 as of July 1, 2023. During the plan year, the plan experienced an increase in its net assets of \$17,066,197. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$153,130,969 including employer contributions of \$139,198,628, participant contributions of \$3,887,427, gain from investments of \$10,028,159 and other income of \$16,755.

Plan expenses were \$136,064,772. These expenses included \$4,774,013 in administrative expenses and \$131,290,759 in benefits paid to or for participants and beneficiaries.
