SUMMARY ANNUAL REPORT

This is a summary of the annual report of the Southern California IBEW-NECA Supplemental Unemployment Benefit Trust Fund, E.I.N. 46-7214939, Plan No. 501, for the year ended June 30, 2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$39,945,088 as of June 30, 2023, compared to \$33,664,840 as of July 1, 2022. During the plan year, the plan experienced an increase in its net assets of \$6,280,248. During the plan year, the plan had total income of \$7,254,173 including employer contributions of \$5,947,117, other income of \$2,350 and income from investments of \$1,304,706.

Plan expenses were \$973,925. These expenses included \$327,627 in administrative expenses and \$646,298 in benefits paid to participants.
